We will not be able to easily forget the difficult times we had due to COVID 19.

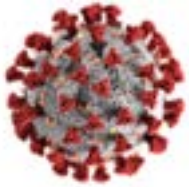
Life goes on! Canine sports must continue!

EXCERPTS DECISIONS TAKEN BY THE GOVERNMENT OF ROMANIA

DECISIONS TAKEN BY THE GOVERNMENT OF ROMANIA

1. In the annex no. 2, article no. 4 contains the following:

„Art. 4. Under the conditions of art. 5 para. (2) let. d) of Law no. 55/2020, with subsequent amendments and completions, it is allowed to participate in one of the activities provided in Annex no. 3 art. 1 points 6, 9 and 12, art. 6 points 1, 2 and 6, art. 9 points 1, 2, 4, 6 and 7, as well as art. 11 para. (2), only to persons who are in one of the following situations:

a) are vaccinated against SARS-CoV-2 virus and for which 10 days have passed since the completion of the vaccination schedule;

b) the period between the 15th and 180th day after confirmation of SARS-CoV-2 infection.

Under the conditions of art. 5 para. (2) let. d) Law no. 55/2020, with subsequent amendments and completions, access is allowed, according to art. 12 para. (4) annex no. 3, only to persons who are vaccinated against SARS-CoV-2 virus and 10 days have passed since the completion of the vaccination schedule, to persons who tested negative for an RT-PCR test for SARS-CoV-2 virus infection not older than 72 hours or the certified negative result of a rapid antigen test for SARS-CoV-2 not older than 48 hours, and persons between the 15th and 180th day after the day of the confirmation of SARS-CoV-2 virus infection.

(2) Individuals are obliged to prove the situations provided in para. (1) and (2) with digital certificates of the European Union regarding COVID-19, in accordance with the provisions of the Government Emergency Ordinance no. 68/2021 on the adoption of measures for the implementation of the European framework for the issuance, verification and acceptance of the European Union digital certificate regarding COVID to facilitate free movement during the COVID-19 pandemic, as subsequently amended and supplemented.

(3) In the case of individuals from states whose authorities do not issue digital certificates of the European Union regarding

COVID-19 or documents compatible with these certificates, the proof of the situations provided in para. (1) and (2) shall be made with a document, on paper or digital format, certifying the vaccination, testing or cure of SARS-CoV-2 virus infection. “

2. Annex no. 3 is replaced by the Annex which is part of this decision.

Art. II. — This decision comes into force on October 25, 2021.

MEASURES

for reducing the impact of each type of risk

Art. 1. - Under the conditions of art. 5 para. (3) let. a) Law no. 55/2020 regarding some measures to prevent and combat the effects of the COVID-19 pandemic, as subsequently amended and supplemented, the following measures are established:

1. to prevent the spread of SARS-CoV-2 virus infections it is prohibited the organization and conduct of rallies, demonstrations, processions, concerts, shows, training courses, workshops, conferences or other meetings, the organization of private events (weddings, baptisms, meals and similar events), as well as gatherings of cultural nature, scientific, artistic, sporting or entertainment activities in open or closed spaces, with the exception of those organized and held in accordance with points 2 to 13;

4. in closed or open spaces, sports competitions may take place in Romania without the participation of spectators, under the conditions established by the joint order of the Minister of Youth and Sports and the Minister of Health, issued pursuant to art. 43 and art. 71 para. (2) Law no. 55/2020, with subsequent amendments and completions;

6. under the conditions of point 5, the organization and activity in cinemas, performance institutions and/or concerts in closed or open spaces are allowed with the participation of the public up to 30% of the maximum capacity of the space and wearing a protective mask. Participation is allowed only for people who are vaccinated against SARS-CoV-2 virus and for whom 10 days have passed since the completion of the vaccination schedule, respectively persons who are between the 15th and 180th day after confirmation of infection with the SARS-CoV-2 virus, under the conditions established by the joint order of the Minister of Culture and the Minister of Health, issued pursuant to art. 44 and

art. 71 para. (2) Law no. 55/2020, with subsequent amendments and completions;

9. outdoor recreational and sporting activities are allowed with the participation of up to 10 people who do not live together. Participation is allowed only for persons who are vaccinated against SARS-CoV-2 virus and for whom 10 days have passed since the completion of the vaccination schedule, respectively persons who are between the 15th and the 180th day after confirmation of infection with the SARS-CoV-2 virus, under the conditions established by the joint order of the Minister of Health, depending on the case, with the Minister of Youth and Sports, the Minister of Environment, Water and Forests or the Minister of Agriculture and Rural Development;

Art. 2. — (1) Under the conditions of art. 5 para. (3) let. b) Law no. 55/2020, with subsequent amendments and completions, the following measures are established:

1. in all localities the movement of persons outside the household is prohibited during hours 22.00—5.00, with the following exceptions:
a) traveling for professional reasons, including between home and the place/places where the professional activity takes place and back;

b) traveling for medical assistance that cannot be postponed or performed remotely, as well as for the purchase of medicine;

c) traveling outside the localities of individuals who are in transit or make journeys whose time interval overlaps with the prohibition period, such as those made by plane, train, bus or other means of passenger transportation, and can be proved by ticket or any other way of trip payment;

d) traveling for justified reasons, such as childcare, assistance to the elderly, sick or disabled or the death of a family member.

2. the measures established at point 1 shall not apply to individuals who are vaccinated against the SARS-CoV-2 virus and for whom 10 days have passed since the completion of the vaccination schedule, and to individuals who are between the 15th day and the 180th day after confirmation of infection with the SARS-CoV-2 virus and proving that this condition is met by means of a vaccination certificate, on paper or in digital format, or by the European Union digital certificate regarding COVID-19;

3. The measures established in points 1 and 2 shall not apply to

individuals from countries whose authorities do not issue European Union digital certificates for COVID-19 or documents compatible with such certificates, vaccinated against SARS-CoV-2 virus and for which 10 days have passed since the completion of the vaccination schedule, ie between 15 and 180 days after confirmation of SARS-CoV-2 infection and proof of this condition with documents, on paper or in digital format, attesting to the vaccination or cure of SARS-CoV-2 virus infection.

1. canceling of flights performed by aviation operators to and from countries not subject to the quarantine / isolation exception established by the National Institute of Public Health and approved by the National Committee for Emergency Situations and from these countries to Romania for all airports in Romania, according to art. 37 Law no. 55/2020, with subsequent amendments and completions, is approved by decision of the National Committee for Emergency Situations;

2. the following categories of flights are exempted from the provisions of point 1:

a) performed with state aircraft;

b) freight and/or correspondence;

c) humanitarian or emergency medical services;

d) for search-rescue or intervention in emergency situations, at the request of a romanian public authority;

e) with the purpose of transporting the technical intervention teams, at the request of the romanian economic operators;

Art. 6. - Under the conditions of art. 5 para. (3) let. f) Law no. 55/2020, with subsequent amendments and completions, the following measures are established:

1. activity with the public of the economic operators carrying out activities of preparation, selling and consumption of food and alcoholic and non-alcoholic beverages, such as restaurants and cafes, inside buildings and on terraces is allowed up to 50% of the maximum capacity in the time interval 5.00—21.00. Participation is allowed only for individuals who are vaccinated against SARS-CoV-2 virus and for whom 10 days have passed since the completion of the vaccination schedule, respectively individuals who are between the 15th and 180th day after confirmation of SARS-CoV-2 virus infection;

Art. 8. - Under the conditions of art. 5 para. (3) let. f) and art. 33-36 Law no. 55/2020, with subsequent amendments and completions, the following measures are established:

1. air transport shall be carried out in compliance with measures and restrictions relating to the hygiene and disinfection of common areas, equipment and aircraft, procedures and protocols inside airports and aircraft, rules of conduct for air staff and passengers, in order to prevent contamination of passengers and personnel operating in the field of air transport, established by joint order of the Minister of Transport and Infrastructure, the Minister of Internal Affairs and the Minister of Health, issued pursuant to art. 32, 33 and art. 71 para. (2) Law no. 55/2020, with subsequent amendments and completions;

3. road transport is carried out in compliance with measures and restrictions relating to the hygiene and disinfection of means of transport, procedures and protocols within means of transport, the degree and mode of occupation of means of transport, rules of conduct for operators and passengers, as well as informing the personnel and passengers, in order to prevent contamination of passengers and personnel working in the field of road transport, established by joint order of the Minister of Transport and Infrastructure, the Minister of Internal Affairs and the Minister of Health, issued under art. 32, 35 and art. 71 para. (2) Law no. 55/2020, with subsequent amendments and completions;

Art. 9. - Under the conditions of art. 5 para. (3) let. f) Law no. 55/2020, with subsequent amendments and completions, the following measures are established:

1. activity with the public of the economic operators that carry out the activity in closed spaces in the field of gyms and / or fitness is allowed without exceeding 30% of the maximum capacity of the space, ensuring an area of at least 4 sqm for each person. Participation is allowed only for individuals who are vaccinated against SARS-CoV-2 virus and for whom 10 days have passed since the completion of the vaccination schedule, respectively individuals who are between the 15th and 180th day after confirmation of SARS-CoV-2 virus infection;

2. activity with the public of the economic operators carrying out activities of management of the indoor swimming pools is allowed without exceeding 30% of the maximum capacity of the space. Participation is allowed only for individuals who are vaccinated

against SARS-CoV-2 virus and for whom 10 days have passed since the completion of the vaccination schedule, respectively individuals who are between the 15th and 180th day after confirmation of SARS-CoV-2 virus infection;

(2) Under the conditions of art. 5 para. (3) let. f) Law no. 55/2020, with subsequent amendments and completions, the activity of fairs, and flea markets, defined according to art. 7 para. (1) of the Government Decision no. 348/2004, with subsequent amendments and completions, is allowed up to 30% of the maximum capacity of the space, under the conditions established by joint order of the Minister of Development, Public Works and Administration, the Minister of Agriculture and Rural Development, the Minister of Health and the Minister of labor and social protection. Participation is allowed only for individuals who are vaccinated against the SARS-CoV-2 virus and for whom 10 days have passed since the completion of the vaccination schedule, respectively individuals who are between the 15th and the 180th day after confirmation of SARS-CoV-2 virus infection.

(6) In case of individuals from states whose authorities do not issue digital certificates of the European Union regarding COVID-19 or documents compatible with these certificates, the proof of the situation provided in par. (4) shall be made with document, on paper or in digital format, attesting the vaccination, testing or cure of SARS-CoV-2 virus infection.

(7) The provisions of par. (4) and (6) shall also apply to economic operators operating in buildings with private offices in which at least 50 persons operate simultaneously.

Art. 14. - (1) Certification of vaccination, testing or cure of SARS-CoV-2 virus infection shall be carried out by

digital certificates of the European Union regarding COVID-19, in accordance with the provisions of the Government Emergency Ordinance no. 68/2021 on the adoption of measures for the implementation of the European framework for the issuance, verification and acceptance of the European Union digital certificate on COVID-19 to facilitate free movement during the COVID-19 pandemic, as subsequently amended and supplemented.

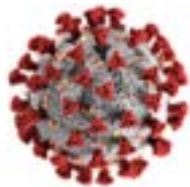
2. Organizers / Economic Operators carrying out activities in

accordance with this Annex shall be required to scan the QR code on the European Union digital certificate for COVID-19 using the "Verification of internal rules" section of the mobile application. "Check DCC" to verify the authenticity, validity and integrity of the certificate, without retaining any data or information from the verified certificate.

3. In the case of individuals from countries whose authorities do not issue European Union digital certificates for COVID-19 or documents compatible with such certificates, the organizers / economic operators carrying out activities under this Annex shall be required to verify the existence of documents, paper or digital format attesting to the vaccination, testing or cure of SARS-CoV-2 virus infection of such persons.

4. The measures provided in this Annex shall not apply to 12 years old or younger individuals and accompanied by a person over 18 years old who demonstrates vaccination against the SARS-CoV-2 virus; and for which 10 days have passed since the completion of the vaccination schedule, respectively between the 15th and 180th day after the confirmation of the SARS-CoV-2 virus infection.

(23) The measures provided in art. 12 para. (1) - (8) shall be implemented by the Ministry of Labor and Social Protection. The application of the measures provided in art. 12 para. (4) and (9) are pursued by the Ministry of Internal Affairs.

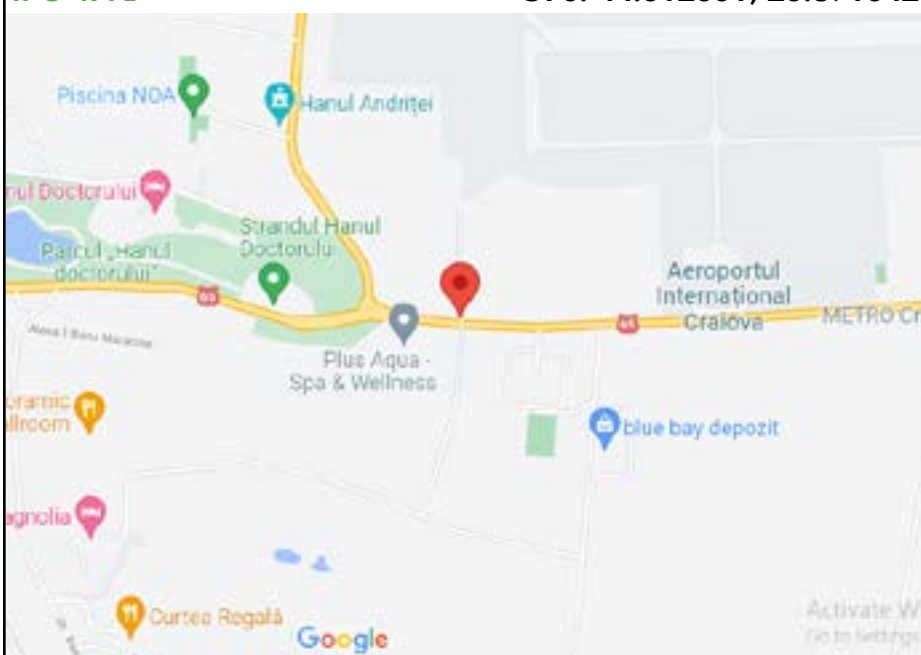
